

Best Practice Standards Network Membership Disclaimer Form

I understand the Best Practice Standards Network and/or the TNT Private Practice Consulting staff, also known as "TNT" have screened, to the best of their ability, the service professionals, also known as "Members". Pre-requisites to membership include the following:

- All members will have completed a quiz on the presented material
- All members will have submitted the practice process form with one blank chart
- All members will have secured an online scheduling system
- Verification of the Member's current licensure status* with the applicant's designated regulatory agency.

Financial Agreement:

You agree to and are financially committed to at least a 6 month membership. TNT offers two membership payment options. You may purchase a 6 month or 12 month membership, with a one time fee of \$275 or \$550 respectively, or you may pay month to month at the rate of \$50/month, with a minimum of 6 months membership term requirement.

TNT accepts payment for your subscription fees and all purchases through PayPal. If you have chosen the month-to-month option, you must give TNT accurate billing and payment information and keep this information up-to-date. You authorize TNT to charge your designated payment method for these charges and to retain information about the payment method associated with your Account. If TNT does not receive payment from your designated payment method, you agree to pay all amounts due upon demand by TNT.

A membership is considered activated on the 1st day of the month and ends on the last day of the month. Termination of membership must be submitted in writing to Tracey Ayers at tayers@btid.com. TNT will retain 6 months of

membership dues, regardless if you are on the one time payment or month to month payment option. This includes 12 month subscriptions. If you have purchased a one payment 12 month subscription, 6 months of the fee will be retained by TNT. Whatever portion remains between 6 months and 12 months of unused dues will be refunded to you at the rate of \$45.83/month. This will be based on when the request for termination has been received in writing.
